#### Jennifer H. Allen

Jennifer H. Allen, Ph.D., is an Associate Professor of Public Administration in the Mark O. Hatfield School of Government and a Senior Fellow at the Institute for Sustainable Solutions at Portland State University (PSU). Her research focuses on sustainable economic development, collaborative approaches to natural resource management, and the integration of sustainability into higher education. Jennifer served as the Director of PSU's Institute for Sustainable Solutions from 2012-2015, and has previously worked at the World Bank, Ecotrust, and the Oregon Economic and Community Development Department. She is currently an Oregon State Parks and Recreation Commissioner and a board member of the World Forestry Center and the Association for Environmental Studies and Sciences; previously Jennifer has served on the boards of the Oregon Forest Resources Institute, Shorebank Pacific, Portland Energy Conservation Inc., Illahee, the Portland Sustainability Institute, Friends of Forest Park, and the Food Alliance. Jennifer holds a B.A. in American Studies from Yale University, a Master of Environmental Management from Yale School of Forestry and Environmental Studies, and a Ph.D. in Environmental Science and Public Policy from George Mason University.

#### Nils D. Christoffersen

Nils D. Christoffersen is the Executive Director of Wallowa Resources, an organization he joined in 1999 as the first Field Program Manager. Wallowa Resources is a community based non-profit working to sustain working lands, and associated livelihoods, in Wallowa County. Over the past 17 years, Mr. Christoffersen has managed the development of Wallowa Resources' watershed stewardship and education programs, as well as their for-profit subsidiary investments in wood products, biomass and renewable energy. In support of the investments in wood products and biomass investments, Mr. Christoffersen has led multiple analyses of raw material supplies, supply chains, and delivered log prices.

He has a Bachelor's in Economics from Williams College (Massachusetts), and a Master's in Forestry from Oxford University (UK). His work experience includes 6 years in Eastern and Southern Africa, with an emphasis on community based natural resource management. Previously, Mr. Christoffersen served as Executive Director for the US Office of Africa Resources Trust, and Regional Program Coordinator for the IUCN's Regional Office in Southern Africa. Short-term engagements include work with the European Commission on matters related to CITES, elephants and

marine mammals, and field work in Australia (livestock), UK (forestry), Norway (forestry and fishing), and Israel (agriculture).

Nils serves on the Oregon Board of Forestry, and is the Chair of that Board's Sub-Committee on Federal Forests. He previously served on the National Commission on Science for Sustainable Forestry (2003-2008), and Chaired the Governor of Oregon's Eastside Forest Advisory Panel from 2003-2005.

# Kaärsten Turner Dalby

Kaärsten Turner Dalby is Vice President of Ecological Services for The Forestland Group. Her management responsibilities include oversight of the FSC certification program, and TFG's efforts to generate increased revenues from a diversity of ecological services including sales of carbon credits and working forest conservation easements, leasing of wind-energy rights and monetization on non-timber attributes associated with forestland ownership. In addition, Ms. Turner Dalby is involved in the development and implementation of forest management plans involving TFG's operational staff and non-affiliated forestry management consultants. Prior to her current role, Ms. Turner Dalby served as Director of Forest Information Systems with management responsibility for the design and implementation of TFG's Forest Information System. Previously, Ms. Turner Dalby served as a Forest Information Analyst and started her employment with TFG as an intern in July of 1998.

Prior to her employment with TFG in 1998, Ms. Turner Dalby consulted with a Boston-based TIMO where she identified and researched a diversity of parameters for agroforestry ventures with non-industrial private landowners in New Zealand. She has worked for a number of domestic and international conservation organizations on public and private land management issues.

Ms. Turner Dalby has a B.A. from Smith College and an M.S. from the University of Montana School of Forestry, and an M.B.A. from the University of North Carolina's Kenan-Flagler School of Business. She has professional affiliations with the Society of American Foresters and the Forest Stewards Guild.

#### **Bruce Daucsavage**

Bruce Daucsavage is the President of Ochoco Lumber Company, formed in the 1920's. He was first hired as a CPA-Controller by the Shelk's 33 years ago. Today, Ochoco Lumber Company employs about 105 people, and owns a sawmill, bio-mass facility, timber lands, land development projects, and trading companies. The company also has years of experience operating in Lithuania and the Russian Far East.

Bruce is currently a member of the Federal Forest Working Group (formed to advance collaboratively active restoration of federal forest lands); Oregon Forest and Industries Council, Wood Products Association (an economic and grading services organization); Oregon Business Council (statewide organization of CEO's); a State community board member of Regence Blue Cross; and a former member of Economic Development of Central Oregon.

For the past few years, he has been working on collaboration in the Blue Mt. Region to advance bio-mass projects utilizing forest restoration products. He has been asked to help, through collaboration with the U.S. Endowment of Forestry in the construction of a torrefaction plant and has had the opportunity to publically speak about our unhealthy forest plight in front of the Administration, Senate and Congressional committees in D.C.

## **Anthony Davis**

Anthony Davis is associate dean for research at OSU's College of Forestry. Davis joined OSU from the University of Idaho, where he served as the director of the Center for Forest Nursery and Seedling Research and as an associate professor of native plant regeneration and silviculture in the Department of Forest, Rangeland, and Fire Science.

Under Davis' guidance at Idaho, the Center for Forest Nursery and Seedling Research became a world-recognized leader in forest nursery science. Davis, who earned his doctorate at Purdue University, has conducted research to improve nursery production practices of native plants, restoration of degraded forests, and has studied the effects of environmental stresses on seedling growth and development.

While at Idaho, Davis received a number of honors. In 2015 he received the Dr. Arthur Maxwell Taylor Excellence in Diversity Award and in 2013 was named the Tom Alberg and Judith Beck Chair in Natural Resources, the first endowed chair at the institution.

In his position at OSU, which began on June 30th, Davis is responsible for the strategic development and the execution of innovative, effective, and respected research programs to help achieve the research mission of the College, Forest Research Laboratory, and the Institute for Working Forest Landscapes.

## **Greg Fullem**
